St Patricks Plain Wind Farm Social and Economic Impact Assessment



As you may be aware, Epuron Projects Pty Ltd is proposing a wind farm on land at St Patricks Plains in the Central Highlands. The proposed site extends from 10 km South of Miena to 25 km north of Bothwell and is shown on the map inset below. The wind farm will involve up to 67 turbines and associated infrastructure and will connect into the existing electricity transmission network crossing the site.

The project requires approval from the Central Highlands Council, the Environment Protection Authority and the Commonwealth Department of Agriculture, Water and the Environment, requiring preparation of an environmental impact statement. Currently a number of studies relating to flora and fauna, wedge-tailed eagles, traffic, heritage, socio-economic factors, noise and visual impacts are being undertaken for inclusion in the environmental impact statement.

pitt&sherry has been engaged by Epuron to prepare an assessment of the social and economic impacts of the proposed wind farm.

This assessment will consider the social or demographic characteristics of the population living in the vicinity of the proposal site, including any special characteristics which may make people more sensitive to impacts from the proposal than might otherwise be expected. It will include an assessment of impacts on local social amenity and community infrastructure, including recreational, cultural, health and sporting facilities and services which will form part of a wider analysis of the benefits and costs of the proposal.

As part of this assessment, we are seeking community feedback to inform the community profile and to gather information about community concerns or interest in the project.

Your comments are important to us. The design of the windfarm will be reviewed twice – once currently and again after completion of two years of on-site studies. An Environmental Impact Statement (EIS) will be lodged with the EPA and Council and in that document we will say how the issues and interests you have raised with us have been noted or reflected in either the design of the wind farm or the EIS document.

Epuron has undertaken informal engagement including:

- a community information session held at Steppes Hall in August 2019
- hosting an information stand at Bushfest Bothwell in November 2019
- held a community information day / public meeting at Miena Community Centre in February 2020
- publishing regular newsletters on the Epuron website and distributing these locally.

At each event the details of interested parties were voluntarily provided for follow up information and engagement and you have provided your details for further involvement. You are being contacted now to seek your formal comments for inclusion in the social and economic assessment.
